



Cabot Moonlighters Disc Golf League RELEASE OF LIABILITY AND ASSUMPTION.

In consideration of the services of Cabot Moonlighters Disc Golf League & CMDGL (herein referred to as CMDGL), their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf, I hereby agree to release and discharge CMDGL, on behalf of myself, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that the activities involved in the participation in any of CMDGL services or promoted third party events, at any given location, entail significant risks, both known and unknown, which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. Such risks include, but are not limited to, damages for negligence, personal injury and/or loss, theft, identity theft, or destruction of personal property.
2. I expressly agree and promise to accept and assume all of the risks existing in these activities, both known and unknown, whether caused or alleged to be caused by the negligent acts or omissions of CMDGL. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.
3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless CMDGL from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or events promoted by CMDGL, including any such claims which allege negligent acts or omissions of CMDGL.
4. Should CMDGL or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.
5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I have no medical or physical conditions that could interfere with my safety in this activity, or else I am willing to assume -- and bear the costs of -- all risks that may be created, directly or indirectly, by any such condition.
6. I agree to the validity and enforceability of this Release of Liability and Assumption of Risk without regard to any conflict with applicable State law.
7. I agree to waive any claims of damages or refund against CMDGL for the failure of a third party event to fulfill their obligations, claims, and/or failure to meet the expectations of the event. Any and all refunds must be sought directly from the third party event and/or its organizers and will not be honored by CMDGL.

8. I agree to abide by the rules and terms of each event.

By checking the box below, I acknowledge that if anyone is hurt or property is damaged during my participation in a third party event, I may be found by a court of law to have waived my right to maintain a lawsuit against CMDGL on the basis of any claim from which I have released them herein. I acknowledge that any refunds from canceled events must be sought directly from the third party event and/or its organizers and not CMDGL.
